All services will be rendered through the Livia MD platform\*, which is a healthcare ecosystem that allows for scheduling patient appointments, obtaining online preauthorization, conducting online consultations, e-prescribing medication, and laboratory and diagnostic imaging tests, submitting e-claims and tracking and receiving payments from insurance companies and other third-party payers.

Additionally, as a provider on our panel, you will be required to have a physical office where clients can walk in for physical consultation when needed. Those admitted to the panel will receive a written confirmation.
