1. PAINTING THEME

2. PARTICIPATING SCHOOLS

"Live free" painting competition targets all primary school children in Competency Based Curriculum (CBC) in Kenya between Grade 1 and Grade 4.

3. CATEGORIES FOR COMPETITION

- i. Grade 1 & 2
- ii. Grade 3 & 4

4. PAINTING RULES AND REGULATIONS

- i. Painting size painting must be done on A4 or A3 papers only.
- ii. Style of painting pupils may use watercolours, coloured pencils, crayons oil paints, charcoal, ink or ANY locally available material.
- iii. Number of paintings/entries accepted pupils may submit up to 3 paintings for consideration in the competition.
- iv. Painting eligibility
 - Paintings must be the original work of the pupil and must be created specifically for this competition. Entries that have been shown or accepted elsewhere will be disqualified.
 - Paintings that show or include a particular person, an organization or a brand name or logo will not be accepted.
 - Submission of the paintings will be in hard copies. The Paintings should be submitted to the Jubilee Life Insurance Ltd by 1st March 2022.

5. PAINTING SUBMISSION FORMAT

A signed submission form must accompany each entry. Please download the entry form from below link on our website (https://www.jubileeinsurance.com/). The submission form must be stamped by the entrant's school to verify the artist is a student at the school. The following information must also be printed (IN BLOCK LETTERS) on the back of each entry:

- Name, age, home address, email address and telephone number of entrant
- Title of entry
- Name, postal address, email address and telephone number of school and Headteacher's name

- **b.** Copyright The artist retains all copyright to their artwork, without exception.
- c. Non-exclusive Permissions By entering this art competition, you are granting Jubilee Insurance and KEPSHA a non-exclusive, perpetual license to reproduce images of your artwork in our 2022 calendar, on our website, in our newsletters/media releases and in the marketing of the art competition to the general public. Works of art will not be used for any other purpose other than these stated above. All finalist entries will be displayed during the awards ceremony at the end of the contest and at any Jubilee Insurance events.
